Conditions for Reproduction and Publication

Images are provided at the discretion of the American Independence Museum (AIM) for personal use, research, and reproduction for purposes relevant to our mission under the conditions outlined below.

DIGITAL IMAGE REPRODUCTION

- The AIM provide high resolution JPEG or TIFF files for the items that are in our collection. This digital reproduction does not give permission to publish – specific permission must be obtained. See Regulations below for more details
- The following fees apply to image reproduction:*
 - \$25.00 per image for items that have previously been digitized
 - \$50.00 per image for items that have not previously been digitized
- Images that require specific equipment or handling to digitize may be priced on an individual basis.

*Members of the American Independence Museum receive a 10% discount

PUBLICATION AND EXHIBIT FEES

- Specific permission must be granted by the AIM to publish or exhibit images owned by the AIM. This permission is granted for one-time use only. Copyright clearance is the responsibility of the patron.
- Publishing or exhibiting AIM images are subject to separate fees for publication and reproduction.
 - Nonprofit fees for publication and exhibits are \$25.00
 - Commercial fees for publication and exhibits are \$100.00
- Images that require specific equipment or handling to digitize may be priced on an individual basis
- Any fees must be paid in advance.
- For item(s) without high quality photos- fee will be waived for the party to come and take own photos of the item(s). AIM will still hold the copyright of the images and a copy must be given to the AIM.

REGULATIONS

1. Unless otherwise specified, AIM holds copyright to the images in its collection. Permission is granted for one-time use. Further reproduction is prohibited except as allowed under “fair use” provisions of copyright law.
2. AIM will not grant exclusive rights to the use of its collections to any party or parties, and it assumes no responsibility for claims arising from third parties
3. Parties may not reproduce or create new images by camera, photocopier, scanner or otherwise without AIM’s authorization. AIM requires that a copy of any slide, print, negative, or digital (scanned) image by authorized parties shall be donated to AIM.
4. The credit line “Courtesy of the American Independence Museum, Exeter, NH” must appear directly beneath each published image or material reproduced from AIM’s collections, including electronic images, or such credit must appear in the section devoted to acknowledgments. AIM reserves the right to require a watermark for images used on a Web site.
5. If a photograph of a painting, graphic, document or museum object is cropped in any way, the caption must include the word “detail.” Nothing may be superimposed on images made available from AIM. No image may be altered digitally or otherwise without written permission from AIM. Alterations must be seen and approved in writing by AIM BEFORE publication.
6. AIM requires that at least one copy of the publication/production in which the reproduction appears shall be donated to AIM.
7. AIM reserves the right to deny the use of its collections to any party or parties failing to comply with these conditions.
